We will focus on issues dealing with the perception of corporate defendants and the unique risks and biases encountered defending these types of defendants.

Next we will present a **master class in mediations**. The panel will include both attorneys and insurance insiders who will discuss effective skills and techniques necessary to obtain favorable outcomes for clients. This will include pre-mediation matters such as discovery and disclosure issues, as well as techniques to use at mediation. Next we will deal with **cyber security threats and privacy issues**. This session will cover cyber security issues and the liability exposure that can arise from these threats. We will discuss not only how to prevent risks, but also how to respond in the event there is a cyber security loss.

Lastly, there will be panel discussion on **settlements**. This discussion will include tips of the trade including pre-settlement expectations, preparing clients for a settlement, how to negotiate a settlement, as well as settlement agreements or clauses useful for specific situations.
